Marc Wiener, Community Development Director of Laguna Beach since December 2019, has decided to leave the City effective immediately to pursue other professional opportunities. I wish to thank Marc for his contributions these past 4 years and to wish him well in his future endeavors. Marc is proud of his time in Laguna and of the many friends he made along the way.

Public Works Director Mark McAvoy has accepted my request to serve as Acting Community Development Director while the City conducts a recruitment to fill the vacancy created by Marc Wiener's departure. Throughout this interim period Mark McAvoy will work closely with Assistant Community Development Director Matt Schneider to provide continuity of department leadership that provides services upon which so many residents rely every day. Mark McAvoy is committed to his regular leadership position in Public Works and is not a candidate for the position.

Mark McAvoy has assigned City Engineer Mark Trestik, a 23-year veteran of Laguna Beach, as Acting Public Works Director during his assignment. The two will remain in regular communication to ensure no disruption of operations in Public Works and to facilitate a smooth transition upon McAvoy's return to Public Works. I appreciate the significance of the impact of an organizational transition of this magnitude. I also have enormous confidence, considering all that I have witnessed of the extraordinary capability of the individuals and teams that comprise the City of Laguna Beach, that we will rise to the occasion and thrive.

I encourage employees of the Community Development Department to continue in your effort to provide high quality services to those you serve.
